Meet our Commanders



Cpt. Scott Cottle *Operations Commander*

Captain Cottle was born in Colorado and raised in Wayne County, Ohio. He is a graduate of Smithville High School and studied Political Science at the University of Akron. He finished his time in the Police Academy in 1991 and joined the Summit County Sheriff's Office shortly thereafter as a part-time deputy.

In February 1992, he was hired as a full-time deputy. After one year working in the Corrections Division at the Summit County Jail he was transferred to Patrol, then to the Summit County Narcotics Unit. He was promoted to the rank of Sergeant in 1999. Ten years later in 2009 he was transferred to the Investigations Bureau and was promoted to Lieutenant in 2011. He was later promoted again to Captain in 2019 and became supervisor over both the Investigations Bureau and Patrol.

Captain Cottle helped develop the litter cleanup program for misdemeanor inmates, was involved in the development of the Sheriff's Office Crash Reconstruction Unit, helped form the Summit County Human Trafficking Task Force, and helped organize the Street Crimes Unit in the City of Green.

Captain Cottle has received many commendations throughout his career, including two for his assistance and leadership in locating missing children. He has also earned three Life-Saving Awards during his career. In 2007 and 2019 he was given the Supervisor of the Year award. He has attended numerous leadership trainings and school and received multiple certifications. He has been described by Summit County residents and other local agencies as a "fine public servant," and has been complemented for his "expertise," his "professionalism," and his "willingness to go out of his way."

Captain Cottle has operated a 500-acre cattle farm for the past 25 years. He has three daughters, and in his spare time enjoys deer hunting and drag racing.



Cpt. Matamba Kaalima
Corrections Commander

Captain Kaalima was born in New Jersey and moved to Ohio with his family in the 1980s. He is a graduate of Central Hower High School and attended the National Institute of Technology before joining the Police Academy. Captain Kaalima joined the Summit County Sheriff's Office as a Special Deputy in 2002, then became a part-time Deputy. He was hired full-time in September 2003.

Captain Kaalima has spent his law enforcement career in corrections, a field that he considers his calling. Throughout his time at both the Glenwood Jail and Summit County Jail he rose through the ranks to Sergeant in 2013, Lieutenant in 2016, Administrative Lieutenant in 2019, and was promoted to Captain in 2020.

Captain Kaalima received commendations in 2011 and 2018 for his outstanding administrative leadership. In 2018 he was honored with the Supervisor of the Year award. He has earned certifications in Jail Administration from the National Jail Leadership Command Academy, a Trilogy Award for the completion of leadership courses from the FBI's Law Enforcement Executive Development Association, and is currently working on several future certifications and a BA in Organizational Leadership.

Summit County residents have described Captain Kaalima as "knowledgeable," "professional in look and demeanor," humanitarian," "dedicated, and "so sincere."

Captain Kaalima lives in Akron with his wife and three children. In his spare time, he plays the trumpet and enjoys reading and writing poetry. He is also a published author, with an article he wrote on Field Training Officer and Correctional Training Officer programs appearing in American Jails Magazine.
